14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶

On March 21, 2018, Marchex, Inc. paid a cash distribution of fifty cents (\$0.50) per Class A Common Stock and Class B Common Stock to shareholders of record on March 8, 2018. The Company's Board of Directors declared the dividend on December 12, 2017, payable to the holders of record as of close of business on March 8, 2018. The aggregate amount of the cash distribution to both classes was \$21,911,085.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶

The cash distribution of fifty cents (\$0.50) per Class A Common Stock is a return of capital distribution to the extent of the shareholder's basis in the stock. The shareholder should reduce the tax basis in each Class A Common Stock by fifty cents (\$0.50) but not below zero.

The cash distribution of fifty cents (\$0.50) per Class B Common Stock is a return of capital distribution to the extent of the shareholder's basis in the stock. The shareholder should reduce the tax basis in each Class B Common Stock by fifty cents (\$0.50) but not below zero.

Distributions to shareholders in excess of current and accumulated earnings and profits of a corporation reduce the basis of the shares of the corporation pursuant to Internal Revenue Code section 301 (c) (2) and section 316 (a).

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶

The Company determined that its current and accumulated earnings and profits were deficits as of March 21, 2018.


17 List the applicable Internal Revenue Code section(s) and subsection(s) upon which the tax treatment is based ►
The taxation of distributions to shareholders of a corporation is determined under Internal Revenue Code (IRC) section 301. Specifically, IRC section 301(c)(2) provides that distributions by a corporation from other than current earnings and profits or accumulated earnings and profits is a return of capital distribution to the extent of the shareholder's basis in the stock.

IRC section 316(a)(1) provides that a corporation is to determine current earnings and profits and section 316(a)(2) provides that a corporation is to determine the accumulated earnings and profits.

As of the date of the distribution to shareholders on March 21, 2018, Marchex, Inc. did not have current earnings and profits or accumulated earnings and profits.

18 Can any resulting loss be recognized? ►
No loss can be recognized by the shareholder as a result of the cash distributions made on March 21, 2018.

19 Provide any other information necessary to implement the adjustment, such as the reportable tax year ►
Shareholders should take this information into consideration when preparing income tax returns for the 2018 calendar tax year or a fiscal tax year that includes the date of March 21, 2018.
